Aligners in Complete Care Patients **Dr. Robert Bialock**

January 27, 2023

Prosthetic treatment of adult patients often requires prior orthodontic preparation. As teeth are lost or worn down, they change their position. In order for the restorative treatment to be as predictable and as less invasive as possible and the treatment results to be as aesthetic as possible, prior orthodontic treatment is recommended. During the on-line course, Dr. Robert Białach will present, on the basis of complex cases treated with the Invisalign system every day in the Stankowscy & Białach Stomatologia clinic in Poland, what comprehensive orthodontic treatment looks like. During the course, the patients' Clincheck treatment plans will be presented and the biomechanics of aligner treatment in the central relationship will be explained.

CBCT for Implant Dentistry **Dr. Dania Tamimi**

March 3, 2023

This livestream will provide an in-depth review of the concepts of imaging for implants, including image manipulation to produce clinically-correct cross sections, radiographic anatomy of relevant parts of the head and neck as well as systematic review of a CBCT volume. Dr. Tamimi will discuss the key strategies for avoiding implant complications by understanding the principles of anatomy and occlusion, and emphasize the importance of diagnosing the alveolar process and patient prior to implant treatment planning. This course is critical for any dentist who is practicing implant dentistry, whether they use CBCT imaging or not, as it reviews anatomy relevant to implant dentistry and the fine art of radiographic evaluation of pathology and formation of a differential diagnosis.

Composite & Ceramic Bonding for Function and Esthetics: How, Where & Where **Dr. Dorota Stankowscy**

April 21, 2023

How to use composite and ceramics in complex cases in order to be minimally invasive and yet achieve a durable and aesthetic treatment result. The lecture will demonstrate the use of composite and ceramics in full mouth rehabilitation. Based on clinical cases, the so-called WIDIOM Rule (Would I Do It On Me?) will be presented. The lecturer's almost 20-year experience of working with patients has helped to prioritize patient treatment and clinical decision-making in the choice of material that will meet the expectations of both patient and clinician. Step-by-step procedures for adhesive cementation of direct and indirect restorations made of composite and ceramic materials will be presented. The idea of minimally invasive treatment, which aims to provide the patient with the best possible results without excessive interference with the tooth tissue, will be explained. All this based on a multidisciplinary treatment that is possible for any dentist.

Managing White Spots and other Discolorations **Dr. Augusto Robles**

Spots in the front teeth have been an esthetic problem for a significant number of people and the options to address it have been mostly invasive with a significant amount of tooth structure as a biological cost. In this course we will examine the causes of these unesthetic spots, the most common diagnoses, and establish a workflow from first observation to treatment decision. We will review the most conservative approaches currently available and discuss individual versus combination approaches and also how to sequence treatment.

Living on the Edge: Incisal Edge Position for Esthetics, Function **Dr. Leonard Hess**

Incisal edge position in every patient is critically important for long lasting comfort and functional esthetics. While many dentists understand how to figure out the vertical component, most dentists do not understand the critical horizontal component of the incisal edge position for predictable and long term success. This horizontal incisal position is a key component for envelope of function, proper speech, balance in the neutral zone, anterior guidance, and also esthetics as related to perceived length. This course will aid you in understanding why the patient was in a position to need the incisal edges restored, and more importantly, learn how to esthetically and functionally restore challenging cases for long lasting results.
